As required by Elkhart Environmental's IDEM permit, a Waste Acceptance Form must be completed for each load. The forms will be supplied by Elkhart Environmental. A copy is attached for your reference.

### Hours:

Monday to Friday 7:00 am to 5:00 pm

Saturday 8:00 am to 12:00 noon

Additional fee of \$25.00 per load to open facility one hour early or one hour late.

Additional fee of \$75.00 per load to have facility opened at other times (evenings, Saturday afternoon, or Sundays)

### Rates:

Septage and Portable Toilet Waste      \$0.08 per gallon

Grease Trap Wastes      \$0.16 per gallon

Solids      \$90.00 per cubic yard

Other waste pricing based on specific waste stream.

Minimum Charge 1,000 gallons per load

### Unloading:

The facility can adapt to your quick disconnect in 3", 4", and 6". If you have special requirements please get in touch with the facility.

### Waste Acceptance Form:

As required by Elkhart Environmental's IDEM permit, a Waste Acceptance Form must be completed for each load. This form will be completed when the load arrives at the facility by an Elkhart Environmental operator. A copy is included in the Policies and Procedures Manual for your reference.

### Invoicing:

The volume discharged will be measured by a calibrated flow meter and invoiced at the gallonage reading with a minimum 1,000 gallon charge. Mixed loads (septage and grease trap waste) will be accepted. Invoicing will be weekly with payments due within thirty(30) days of the date of the invoice.

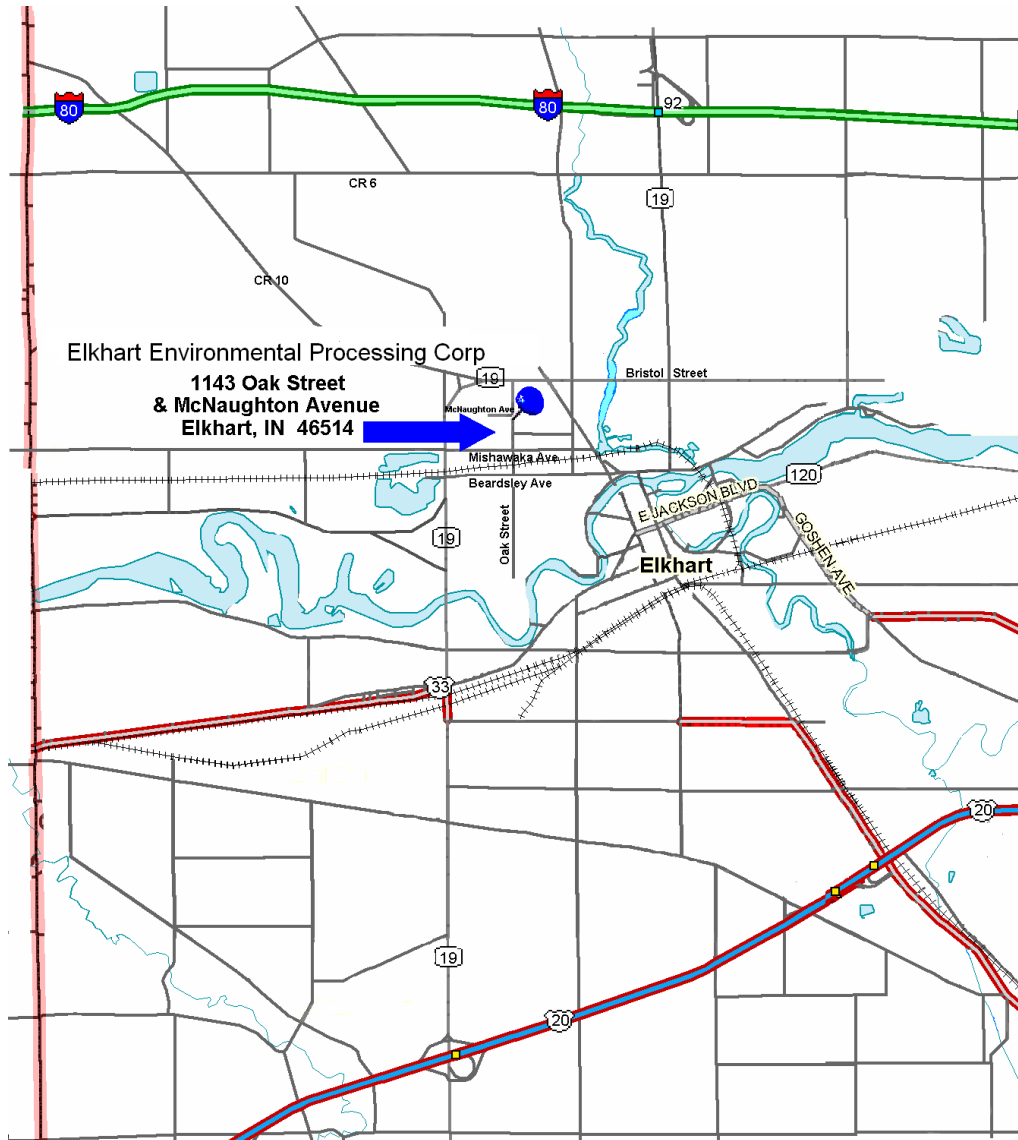

Directions from the Southwest and Southeast:

Route 20 to Route 19 North (Nappanee Street), after Route 19 bends to the East it becomes Bristol Street. Oak Street is first street on the right hand side.

Directions from the Northwest and Northeast:

Toll Road (Route 80/90) to Exit 92, go South on Route 19 (Cassopolis Street). After Route 19 turns West it becomes Bristol Street, go through 3 traffic lights, Oak Street is on the left hand side.

Once on Oak Street, go one block to right onto McNaughton Ave to Elkhart Environmental's entrance. The entrance is on left just before the Wells Cargo's entrance gate.
